The purpose of the revised FEAF Part 1 is to give notice to the involved and interested agencies of the change in the alignment of a portion of the water transmission main in the Town of Canandaigua.. 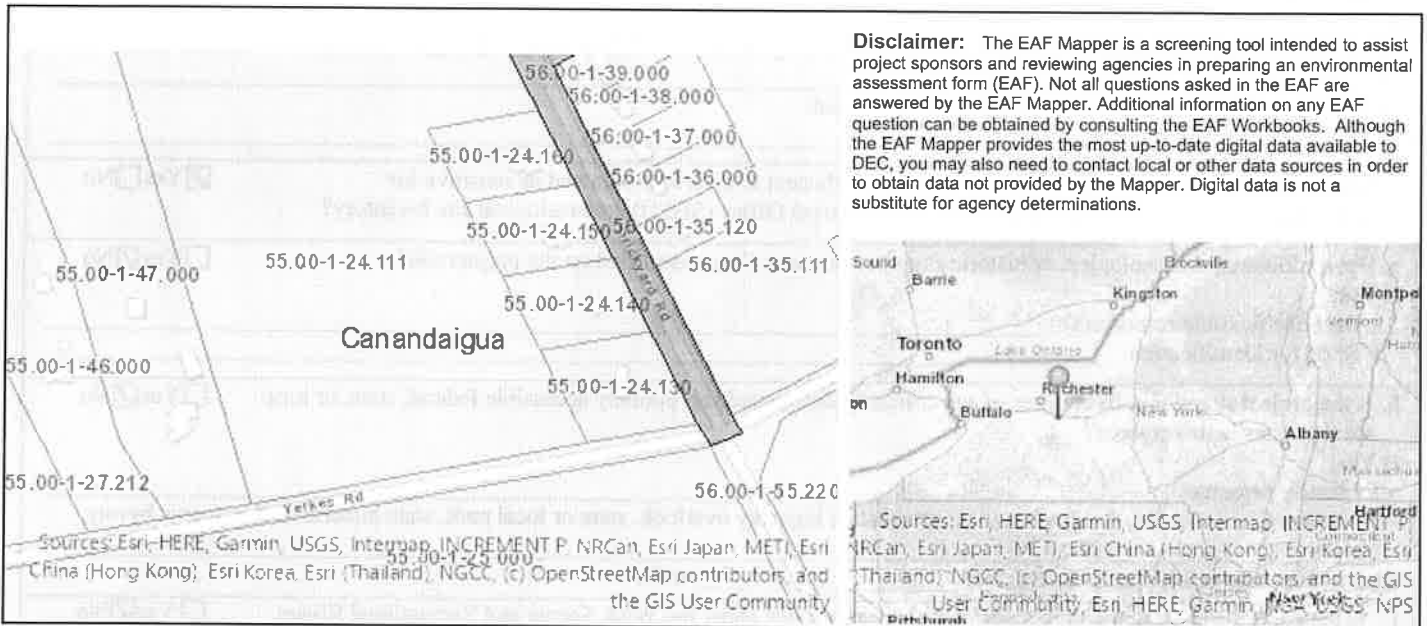
